- (1) <u>Call to Order:</u> The Board of Mayor and Aldermen met in regular session on Tuesday, January 22, 2013; in the Municipal Building Court Room at 7:00 p.m. Mayor John Holden presided. The meeting opened with prayer by Alderman Robert Taylor Jr. Mayor Holden noted all Aldermen were present.

- (4) New Business:

a. Neel Durbin - Dyersburg City Schools Director

Mr. Durbin provided the Board with updated information regarding the success of student ACT score improvements over the past several years. He praised the efforts of the teachers and staff in the Dyersburg City School System for their hard work in this student achievement. Of special note is the significantly high ranking position of student scores that includes students with economic disadvantages.
