- (1) <u>Call to Order:</u> The Board of Mayor and Aldermen met in regular session on Tuesday, January 21, 2014; in the Municipal Building Court Room at 7:00 p.m. Mayor John Holden presided. The meeting opened with prayer by Mayor Holden. Mayor Holden noted all Aldermen were present.
- (2) <u>Approval of Minutes:</u> With minor corrections noted the minutes of the January 6, 2014 meeting were approved on a motion by Alderman Kevin Chaney, followed by a second from Alderman Terry Glover. The motion passed approving the minutes.
- (3) <u>Unfinished Business:</u> There was no unfinished business.

(4) <u>New Business</u>:

- a. Public Hearing An Ordinance to amend the Dyersburg Municipal Zoning Map to rezone property on Pioneer Road & St. John Avenue (B&B Partners) from B-1 (Limited Trade & Services) to P-B (Planned Business) BB629. At the January 6, 2014 the Board approved the recommendation for the Regional-Municipal Planning Commission and A notice of public hearing announcement was presented at the January 6, 2014 Board meeting and the announcement was advertised in the State Gazette newspaper. Alderman Bob Kirk motioned the Board to approve the zoning amendment BB629, as presented before the Board of Alderman by the Municipal-Regional Planning Commission. - Announced that citizens would be receiving mail regarding information about the City's "Ready Dyersburg" campaign. The information will provide emergency contact numbers information on what to do in the event of an emergency or a natural disaster.
