Mayor Holden presented the recent opportunity for award to be presented to the City of Dyersburg for the purpose Disaster Relief Appropriations Act (Public Law 113-2,

approved January 29, 2013) providing for disaster relief for unmet needs, long term recovery and restoration of infrastructure, housing and economic revitalization resulting from severe weather in the state that occurred during 2011 and 2012, for which the President declared major disasters under Title IV of the Stafford Disaster Relief and Emergency Assistance Act.

The U.S Department of Housing and Urban Development (HUD) an appropriation of Community Development Block Grant (CDBG) funding associated with disaster relief is to be granted to eligible entities. The resolution reads as follows:

DYERSBURG, TENNESSEE

WHEREAS, the Disaster Relief Appropriations Act (Public Law 113-2, approved January 29, 2013) provides for disaster relief for unmet needs, long term recovery and restoration of infrastructure, housing and economic revitalization resulting from severe weather in the state that occurred during 2011 and 2012, for which the President declared major disasters under Title IV of the Stafford Disaster Relief and Emergency Assistance Act.

WHEREAS, this Act provides the U.S Department of Housing and Urban Development (HUD) an appropriation of Community Development Block Grant (CDBG) funding associated with disaster relief to be granted to eligible entities.

WHEREAS, the City of Dyersburg acting by and through its Board of Aldermen proposes to apply for Community Development Block Grant Disaster Recovery funds for the purpose of performing eligible activities that will benefit the majority of the residents in Dyersburg.

WHEREAS, the City of Dyersburg will provide local financial support in conjunction with the CDBG Disaster Recovery funds to complete the grant activities; and

WHEREAS, the City of Dyersburg as a recipient of CDBG Disaster Recovery funding hereby designate and appoint a Financial Officer to perform certain duties in the administration of said grant.

NOW, THEREFORE, BE IT RESOLVED by the Board of Aldermen of the City of Dyersburg as follows:

THAT, John Holden, Mayor, is hereby authorized to execute and submit an application with appropriate assurances to the State of Tennessee, Department of Economic and Community Development, Office of Federal Programs, requesting Community Development Block Grant Disaster Recovery funds in the amount not to exceed \$250,000 for a CDBG-Disaster Assistance project; and

THAT, John Holden, Mayor, and his successor in title, be and is hereby designated and appointed as Financial Officer under the terms and conditions of the CDBG Disaster Recovery program and governing, laws, policies, procedures, and to perform on behalf of Dyersburg, Tennessee, those acts and assume such duties as are consistent with said position.
