### BOARD MEETING Thursday, February 20, 1873 Court House

The Board of Mayor and Aldermen of Dyersburg met at the Court House this 20<sup>th</sup> day of February, 1873.

Present Mayor Clark, Aldermen Coker, Finner, DeBerry, McAllister and Doyle and Marshal Nichols.

The minutes of the last meeting were read, approved and signed.

Ordered that the Marshal report to the next meeting of the Board, a list of all due and unpaid taxes due from the years 1870-1871 and 1872, and also the unpaid fines.

On motion C.J. Coker is hereby appointed to look after the streets, bridges and to have any repairs done as are immediately required.

The Finance Committee submitted the following report which was received and ordered of second to wit:

To the Mayor and Aldermen of Dyersburg, Tennessee:

Your undersigned Finance Committee beg leave to report the subjoined settlements made this day with the Marshal and Recorder and Treasurer, from which it appears that the Marshal has collected from all sources up to this date the sum of \$998.83 from which his \_\_\_\_\_\_\_ \$49.94 is deducted, leaving \$943.89 net funds in his hands, while he is entitled to credit for \$200.00 for his salary, and has paid into the Corporation Treasury \$853.41, so that the Mayor and Aldermen owe Marshal Nichols \$104.52.

That the Recorder & Treasurer has collected from all sources the sum of \$1,139.70 and has paid out as per proper vouchers the sum of \$1,046.86 leaving in the Treasurer's hands now \$92.84.

All which is respectfully submitted February 17<sup>th</sup> & 10, 1873.
