BOARD MEETING October 1, 1874 Court House

The Board of Mayor and Aldermen of the Town of Dyersburg met in regular meeting at the Court House on this Thursday evening October 1, 1874.

Present Mayor Neal and Aldermen Wilson, Deberry, Sampson, Thurman, Sugg and White and Marshall McClerkin.

The minutes of the last meeting were read, approved and signed.

The committee on Work House was continued.

The committee appointed to settle with Ex Marshall Nichols made their report when on motion an account of Jno. M. Nichols for (\$50.00) fifty dollars money paid out by him for Corporation purposes was allowed, also one for \$200.00 Two Hundred Dollars for his services as Town Marshall and street supervisor from 1st January 1874 to 1 Sept. 1874.

On motion the following accounts was allowed:

Thomas Kelly's acct. \$10.20 for jail fees to 1st October

W. D. Norred acct. \$2.50 hauling brush

H. W. Vaughn \$5.00 for Smith's work

Thomas W. Neal \$10.00 for printing

Stevens Bros. \$242.25 for lumber acct.

Note: \$13.30 of the amt. allowed Stevens Bros. was contracted for by the Board of Mayor and Aldermen for 1873, it being for saw dust and lumber furnished them by same Stevens Bros.

On motion an account of Jno. Harten for \$45.00 was referred back to the finance committee also one in favor of C. C. Moss Esq. for \$50.00.

On motion the Mayor appointed Marshall McClerkin Fire Warden.

On motion the Marshall was ordered to put the Troy Street, entering McGaughey Street, in good repair before the winter sets in.

On motion Board adjourned.
