The Aldermen elect for the Town of Dyersburg for the year 1875 met at the Court House in Dyersburg, Dyer County, Tennessee and presented their Certificate of Election to F. G. Sampson an acting Justice of the Peace for Dyer County, to wit:

State of Tennessee

Dyer County

I, Jno. M. Nichols, Sheriff of said County, do certify that at the election held for Aldermen at the Court House in the town of Dyersburg on the 2nd day of January, 1875 A. M. Stevens, W. E. Deberry, N. C. White, E. G. Sugg, E. S. Thurman, J. C. Pinner & William Turner, was duly and constitutionally elected Aldermen of the Town of Dyersburg for the year 1875.

Given under my hand at office this the 4th day of January 1875.

Whereupon the Aldermen Elect (except W. E. Deberry who was not present) were duly sworn by F. G. Sampson I. P.

The Board then proceeded to the election of Mayor for 1875 by ballot, when E. G. Sugg was duly elected and sworn by F. G. Sampson I.P.

The Board then proceeded to the election of Recorder & Treasurer for 1875 when N. C. White was duly elected.

The Board then proceeded to the election of Marshall for the year 1875 when James H. Fowlkes was duly elected and sworn by F. G. Sampson, I. P.

On motion it was ordered that the Recorder & Marshall be required to execute their Bonds in the amt. of Ten Thousand Dollars each.

On motion it was ordered that the regular meeting of the Board be changed from the $\mathbf{1}^{st}$ Thursday in each month to the $\mathbf{1}^{st}$ Tuesday night in each month.

On motion the Mayor was requested to appoint a Fire Warden wherefrom he appointed Alderman Turner Fire Warden.

On motion it was ordered that the Board meet on Monday night next to receive the Bonds of the Recorder and Marshall.

On motion the Board adjourned.
