BOARD MEETING March 6, 1883 Court House

Be it remembered that a regular meeting of the Board of Mayor and Aldermen for the Town of Dyersburg was held in Court House on Tuesday night March 6, 1883.

Present Mayor B. L. Thomas, Aldermen J. C. Pinner, A. B. Jones, Ed Smith, W. R. Hayes and Marshal Thurmond.

Minutes of last meeting read and signed. On motion report of committee on horse racks read and committee discharged.

On motion committee on Calaboose allowed further time to report.

On motion committee on walk south of Pinney's allowed further time to report.

On motion Z. G. Watkins, A. B. Jones and J. W. Baker were instructed to have walk put down on street east of G. B. Millers and north of Sawyer's Hall, also to extend walk on Sampson Street if in their judgment these walks aught to be built at present and make report at next meeting of Board.

On motion account in favor A. W. Stevens for (\$44.22) Forty four and 22/100 dollars allowed.

On motion account in favor Mr. Atkins for (3.50) three and 50/100 dollars work on rack allowed.

On motion account in favor J. P. Tinner jail fees (5.60) five and 60/100 dollars allowed.

On motion account in favor E. C. Pate for one & 80/100 dollars allowed.

On motion account in favor S. G. Parks for twenty five dollars for running water on lot allowed.

On motion Ed Smith, J. C. Pinner and W. R. Hayes was appointed to make settlement with J. W. Nichols on claims for money paid W. B. Tarrant jail fee 1882, \$15.00 dollars paid Ben Harton and motion was allowed.

On motion account Latta and Richardson for (10) ten dollars legal advice in Burke case allowed.

On motion Ed Smith and Zach Watkins were appointed to investigate claim of Latta and Marshal for services in Circuit Court and report next meeting on same.

On motion report of W. R. Hayes Recorder on uncollected taxes read and ordered filed with papers.

On motion account in favor Dyer County J. M. Nichols Commissioner for ten dollars bridge lumber allowed. Hog ordinance – on motion Marshal was instructed to give ten days notice and at expiration of that time take up as a nuisance all hogs found running at large within the Corporation limits and charge .50 cents for each head and .10 cents for offspring each head per day. Hogs to be advertised day they are taken up and sold at the expiration of five days if not called for by their owners.

On motion Miss Jackson and Nichols were requested to order one street lamp for Corporation.

On motion Marshal Thurmond was instructed to have walk run north of M.M. Marshall's residence provided all lumber for same is furnished without cost to Corporation.

On motion Board adjourned.
