## MINUTES OF THE MEETING BOARD OF MAYOR AND ALDERMEN June 7, 2004

The Board of Mayor and Aldermen for the City of Dyersburg met in regular session on Monday night, June 7, 2004 in the Municipal Courtroom at 7:00 p.m.

Mayor Revell presided with all Alderme n present except Alderman McCright.

The meeting opened with the "Pledge of Allegiance to the Flag" followed by prayer by Alderman Norman.

Minutes of the meeting of May 17, 2004 were approved.

### PUBLIC HEARING - GREASE TRAP ORDINANCE - ORDINANCE BB-554

On a motion by Aldermen Lee and Dean a grease trap ordinance was adopted.

### PUBLIC HEARING - PRDO HAMPTON PLACE - ORDINANCE BB-555

On a motion by Aldermen Dudley and Kirk a Planned Residential Development Overlay (PRDO) was approved for 34 lots on 17.8 acres on the north side of Wade Hampton Road.

## PUBLIC HEARING – REZONE R-1 TO R-3 – LAKES AT THE FARMS – SECTION D

Residents of Pioneer West opposed the zoning change due to concerns about increased traffic, drainage, access by emergency vehicles, and possible property devaluation. Mr. Tony Hartfield spoke on behalf of his fellow neighbors.

Attorney John Palmer represented the owners and countered the objections that were raised.

The rezoning was denied by unanimous roll call vote on the motion by Aldermen Lee and Dean.

### SCHOOL SYSTEM BUDGET – 2004-2005

Schools Director Lloyd Ramer presented the Dyersburg City Schools 2004-2005 budget totaling \$19,700,000.

The budget was approved on a motion by Aldermen Norman and Lee.

# <u>CITY BUDGET – 2004-2005</u>

Mayor Revell presented a proposed no property tax increase, balanced budget for 2004-2005. The total budget is \$40,289,520 with a general fund budget of \$14,408,000.

## POLICE VEHICLES – BUDGET AMENDED

On a motion by Aldermen Dudley and Dean the 2003-2004 budget was amended to expend \$38,000 for the purchase of two police cars.

## STREET COMMITTEE REPORT

Street Committee Chairman Freeman Dudley reported on the meeting of June 1, 2004. On a motion by Aldermen Dudley and Dean the Board approved construction of a left turn lane on Pennell Lane at Lake Road.

### **CEMETERY COMMITTEE REPORT**

Mayor Revell reported on the Cemetery Committee meeting of June 1, 2004. City Attorney John Lannom had reported on the investigation into allegations of wrongdoings at the cemetery. He stated that the allegations were false and the City had done nothing wrong.

On a motion by Aldermen Lee and Dean the Board approved all necessary corrective action to reassign the burial plots for the Presslar family, Mrs. Shannon and the Gerald Ketchum family.

### MISC.

<u>Alderman Dean</u> requested that the City run a newspaper ad outlining the dates for curbside pickup.

Alderman Lee called for prayers in remembrance of President Reagan.

<u>Alderman Norman</u> inquired about when improvements would be made to Wade Hampton Road.

There being no further business the meeting adjourned at 8:01 p.m.
