## Board of Mayor and Aldermen City of Dyersburg January 22, 2008

The Board of Mayor and Aldermen met in regular session on Tuesday, January 22, 2008 in the municipal courtroom at 7 p.m.

Mayor John Holden presided with all Aldermen present.

The meeting opened with the "Pledge of Allegiance to the Flag" and prayer by Alderman Bart Williams.

<u>Resolution 012208 – Requesting Assistance of MTAS in Preparing a Comprehensive</u> Management Review and Authorizing the Mayor to Execute an Agreement

On a motion by Aldermen Dudley and Walker the following resolution was adoption:

#### Resolution No. 012208

A RESOLUTION OF THE CITY OF DYERSBURG BOARD OF MAYOR AND ALDERMEN TO REQUEST THE ASSISTANCE OF THE UNIVERSITY OF TENNESSEE'S MUNICIPAL TECHNICAL ADVISORY SERVICE IN PREPARING A COMPREHENSIVE MANAGEMENT REVIEW AND AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT FOR SAME.

WHEREAS, the Board of Mayor and Aldermen of the City of Dyersburg desire to have the University of Tennessee's Municipal Technical Advisory Service, hereinafter referred to as "MTAS", perform a comprehensive review of all Dyersburg municipal services; and

WHEREAS, MTAS has personnel with experience in conducting such studies for Tennessee municipalities and has agreed to perform the comprehensive management review at no cost to the City of Dyersburg.

NOW, THEREFORE, in consideration of these facts be it resolved by the Board of Mayor and Aldermen of the City of Dyersburg, as follows:

- 1. Request for assistance. The Board of Mayor and Aldermen of the City of Dyersburg hereby officially requests MTAS to undertake and complete a study of Dyersburg's municipal management and operations for the purpose of identifying ways and measures to improve municipal service delivery, reduce costs, and enhance revenues.
- 2. <u>Mayor authorized to sign agreement with MTAS</u>. The Mayor of Dyersburg is hereby authorized to enter into an agreement with MTAS, attached to and made a part of this resolution, for the purpose of obtaining the described in Section 1.
