# Board of Mayor and Aldermen City of Dyersburg June 16, 2008

The Board of Mayor and Aldermen met in regular session on Monday, June 16, 2008 in the municipal courtroom at 7 p.m.

Mayor John Holden presided with all Aldermen present except Alderman Kevin Chaney.

The meeting opened with the "Pledge of Allegiance to the Flag" followed by prayer by Alderman Bart Williams.

The minutes of the June 2, 2008 meeting were approved on a motion by Aldermen Norman and Williams.

### 2007-2008 Budget Amended

City Treasurer Steve Anderson requested approval of expenditure and revenue amendments to the 2007-2008 budget. The 2007-2008 budget was amended on a motion by Aldermen Kirk and McCright.

Mr. Anderson explained that property tax information will not be available until mid July. On a motion by Aldermen Norman and Williams, the board approved a continuation budget until the 2008-2009 budget revenues can be finalized.
