## Board of Mayor and Aldermen Meeting Monday, May 2, 2011, 7:00 P.M. Municipal Building – Courtroom

- (1) <u>Call to Order:</u> The Board of Mayor and Aldermen met in regular session on Monday, May 2, 2011 in the municipal courtroom at 7:00 p.m. Mayor John Holden presided. All Board members were present. The meeting opened with the "Pledge of Allegiance to the Flag" followed by prayer by Terry Glover.
- (2) <u>Approval of Minutes:</u> Minutes of the April 18, 2011 meeting were approved on a motion by Mr. Kevin Chaney, followed by a second from Mr. Bart Williams. The motion passed approving the minutes.
- (3) **<u>Unfinished Business</u>**: None to report.
- (4) New Business:

## c. Disaster Recovery Services (DRS) Update – May 2010 Flood:

A report from Disaster Recovery Services (DRS) was requested by Mayor Holden and City Aldermen regarding the organization's work over the past year. DRS President Gary Meade provided a detailed overview of the scope and sequence of services offered to the 2010 flood disaster victims provided by the organization, its many volunteers, and financial supporters. On behalf of the Mayor and Alderman, Alderman Bob Kirk, Chairman of the Public Safety Committee, presented plaques to the members of the DRS Executive Committee for their service to the community since the flooding on May 3, 2010. Gary Meade of St. Mary's Episcopal Church, Robert Craig of First United Methodist Church, Amy McDonald of Matthew 25:40, Debbie Todd of the United Way of West Tennessee, and Brooke Emery were each presented plaques for their continued service to Dyersburg flood victims over the past year.

#### d. City of Dyersburg response to recent potential flooding:

Dyersburg Emergency Operations Manager Mark Grant reported on the current flood conditions of the Forked Deer and Mississippi rivers. Mr. Grant gave a detailed date, time, and response reference to the pre-planning for flood disaster from April 25, 2011 to the present date.
