# Board of Mayor and Aldermen Meeting Monday, September 19, 2011, 7:00 P.M. Municipal Building – Courtroom

- (1) <u>Call to Order:</u> The Board of Mayor and Aldermen met in regular session on Monday, September 19, 2011 in the Municipal Courtroom at 7:00 p.m. Mayor John Holden presided. The meeting opened with the "Pledge of Allegiance to the Flag" followed by prayer by Alderman Kevin Chaney. Mayor Holden noted all Board members were present.
- (2) <u>Approval of Minutes:</u> Minutes of the September 6, 2011 meeting were approved on a motion by Alderman Williams, followed by a second from Mr. Taylor. The motion passed approving the minutes.
- (3) <u>Unfinished Business:</u> None presented.
- (4) New Business:
  - a. Notice of Public Hearing October 3, 2011 Telecommunication Tower Zoning Ordinance October 3, 2011

The proposed rezoning amendment of a Telecommunication Tower Zoning Ordinance was noticed to the public and would be reviewed for final comment at the next scheduled meeting of the Mayor and Board of Alderman, Monday, October 3, 2011. Mayor Holden entertained a motion for the Board's approval of the zoning notice. Mr. Moody moved to approve the proposal review, followed by a second from Mr. Kirk. The motion passed by full Board vote.
