- (1) <u>Call to Order:</u> The Board of Mayor and Aldermen met in regular session on Monday February 20, 2012; in the Municipal Courtroom at 7:00 p.m. Mayor John Holden presided. The meeting opened with the "Pledge of Allegiance to the Flag" followed by prayer by Alderman Dennis Moody. Mayor Holden noted all Board members were present.
- (2) <u>Approval of Minutes:</u> Minutes of the February 6, 2012 meeting were approved on a motion by Alderman Robert Taylor, Jr., followed by a second from Alderwoman Joan Wyatt. The motion passed approving the minutes.
- (3) <u>Unfinished Business:</u> None presented.
- (4) <u>New Business</u>:
 - **a.** Finance Committee Meeting Report February 14, 2012 Chairman Kevin Chaney.

Chairman Chaney read the minutes of the Finance Committee Meeting held February 14, 2012. The Committee heard a project request from Mr. Durbin regarding the replacement of two 1969 model inefficient boilers at Dyersburg High School with 95% efficient boilers replacement of a 430ton inefficient chiller with a very high efficient VFD chiller that also uses environmentally friendly refrigerant. Mr. Durbin stated the City School Board did approve presenting the project before the Finance Committee. The Committee members were provided individual copies of the project proposal that included:
