Calculating Storm Water User Fees

Single-Family Residential User Fee. The fee that residential users within the City limits will be a flat charge of \$1.00 per month. The average square footage of a single-family residential property is equivalent to one “ERU” and is determined to be 1500 square feet from recent U.S. Census Bureau reports.

Developed Property Fee. The fee that developed property users within the City limits will be determined from the following formula:

$$\text{Commercial Property Fee/Month} = \frac{\text{Impervious Area} \times \$1.00 \times 50\% \text{ (correction factor)}}{1500 \text{ sq. ft.}}$$

$$\text{Industrial Property Fee/Month.} \frac{\text{Impervious Area} \times \$1.00 \times 25\% \text{ (Correction Factor)}}{1500 \text{ Sq Ft}}$$
