# **COMMUNICATION FROM THE MAYOR:**

Mayor Holden called the Board's attention to the Dyersburg Police Department Chief Steve Isbell's report that crime has dropped for the second consecutive year in the City of Dyersburg. Mayor Holden also highlighted the placing of 20 Skycop camera locations in the city. Mayor Holden also noted the unemployment rate for the city has declined from 8% in 2020, to 4.9% in 2021, to 3.7% in 2022, and down to 3.6% last year. The Mayor also noted the 2024 residential trash pick-up holiday schedule and gave a phone number for the Sanitation Information Line (731) 288-7030, a hotline which provides the 2024 holiday pickup schedule and any other information about household trash service.
