Present and presiding Mayor B. L. Thomas, Aldermen Watkins, Smith, Turner, Brackin, Sinclair and Hayes – Marshal Edmund L. Smith.

Report of committee on privileges and advalorum tax was read and ? property for year 1886 was read and adopted and is as follows and the rates fixed is hereby levied – Privileges for 1886:

And in addition to the above rate each privilege shall pay 30% for school purposes

Polls – shall each be two dollars – one of which shall be for school purposes.

The Corporation Tax on all property shall be .50 cents on the \$100 dollars - .20 cents of which shall be for school purposes which makes the Corporation tax .30 cents and school tax .20 cents on each one hundred dollars.

On motion committee was appointed to assess that portion of T. J. King's home place which lies out side of the Corporation and the Corporation has said portion assessed for Taxes that it be released. Watkins, Brackin, Turner.

On motion Wm. Turner and Ed Smith were appointed to examine all sheds and awnings and if condemned the Marshal is ordered to have these repaired or torn down.

On motion Wm. Turner was appointed Fire Warden for the year 1886.

On motion a committee was appointed to submit to the Board a list of ordinances for the Corporation of Dyersburg, Tennessee to-wit: Hayes and Watkins

On motion it was ordered that the Marshal immediately make out a list of the uncollected taxes for 1883 – 1884 – and 1885, make affidavit to same and proceed at once to collect them by law if necessary.

On motion Marshal Smith was appointed street commissioner for the year 1886.

No further business appearing, Board on motion adjourned harmony prevailing.
