**On motion committee on extending lease to Cotton Seed Oil Mill discharged, they reporting that lease extended.**

**On motion committee on correspondence with Kashum discharged.**

**On motion the lease to R. R. for building switch as read was approved and ordered signed by Mayor and Recorder.**

**On motion committee was appointed to make report in regard to request of A. M. Stevens to have his lease extended on lot the saw mill is built on – Ed Smith and W. R. Hayes.**
