- (1) <u>Call to Order:</u> The Board of Mayor and Aldermen met in regular session on Monday, February 5, 2018 in the Dyersburg Municipal Court Room at 7:00 p.m. Mayor John Holden presided over the meeting. The meeting opened with prayer by Alderman Kevin Chaney. Mayor Holden noted all Aldermen were present. Mayor Holden recognized and welcomed Alderman Scott Staggs to his first Board meeting.
- (2) <u>Approval of Minutes:</u> Mayor Holden called for a motion to approve the minutes from the December 18, 2017 meeting. The minutes were approved on a motion by Alderman Bill Escue, followed by a second from Alderman Robert Taylor, Jr.

On a motion by Alderman Bob Kirk, and a second by Alderman Terry Glover, the committee voted to approve the Agreement and Fees Schedule to be presented to the full board for approval.

d. Resolution 02052018.

Mayor Holden informed the Board of the requirement authorizing the city to pass a resolution to apply for a Tennessee Community Development Block Grant through the State of Tennessee, Department of Economic and Community Development, Office of Program Management, requesting Fiscal Year 2018 Community Development Block Grant funds in the amount not to exceed \$500,000, plus any eligible Three Star Bonus allowance, for a Sewer System Improvements Project. The grant will be an 80/20 match. The resolution reads as follows:

RESOLUTION NO. 02052018 DYERSBURG, TENNESSEE

WHEREAS, the Tennessee Community Development Block Grant Program has been established to assist local governments in meeting community development and housing needs consistent with the objectives as set forth in Title I of the Housing and Community Development Act of 1974, as amended; and

WHEREAS, the City of Dyersburg acting by and through its Board of Aldermen proposes to apply for Community Development Block Grant (CDBG) funds for the purpose of performing eligible community development activities that will benefit the majority of the residents in Dyersburg.

WHEREAS, the City of Dyersburg will provide local financial support in conjunction with the CDBG funds to complete the above project; and

WHEREAS, under the terms and provisions of Title I of the Housing and Community Development Act of 1974, as amended, Dyersburg as a recipient is required to designate and appoint a Financial Officer to perform certain duties in the administration of said grant.

NOW, THEREFORE, BE IT RESOLVED by the Board of Aldermen of the City of Dyersburg as follows:

THAT, John Holden, Mayor, is hereby authorized to execute and submit an application with appropriate assurances to the State of Tennessee, Department of Economic and Community Development, Office of Program Management, requesting Fiscal Year 2018 Community Development Block Grant funds in the amount not to exceed \$500,000, plus any eligible Three Star Bonus allowance, for a Sewer System Improvements Project; and

THAT, the City of Dyersburg will be responsible for the local cash/match to be provided in full by the sewer fund account; and

THAT, John Holden, Mayor, be and is hereby designated and appointed as Financial Officer under the terms and pursuant to the provisions of Title I of the Housing and Community Development Act of 1974, as amended, and to perform on behalf of Dyersburg, Tennessee, those acts and assume such duties as are consistent with said position.

Alderman Kevin Chaney made a motion to approve the resolution authorization, with a second by Alderman Robert Taylor, Jr. The motion passed.

Reports from Alderman and Alderwomen:

Aldermen Bob Kirk: Requested a meeting with John Lannom to discuss a gun range proposal. Secondly, he inquired as to the availability of the 2016/17 auditors report by the city's auditing firm. Alderman Bill Escue: Commended the various city departments who had to work in extreme weather conditions during the recent severely cold weather experienced in January.

Alderman Terry Glover: Reminded the community of the Dyersburg High School basketball teams season successes for 20171/18 and encouraged the community to support the teams as their seasons are ending.

Alderman Kevin Chaney: No report.

Alderman Mike Morgan: No report.

Alderman Dennis Moody: Inquired about the status of pothole repair in the city. He asked Street superintendent Mike McCulloch if there was any new technology or products available to apply to pothole repair that would be longer lasting and more permanent. Mr. McCulloch stated he was not aware of any improved technology or product.

Alderman Robert Taylor, Jr: Also, inquired as to how citizens can report potholes. Mayor Holden stated citizens should call 311 to help the city determine pothole repair locations. Street superintendent Mike McCulloch noted citizens may call reports into his office, as well as, 311. Mr. McCulloch also stated that the city has distributed approximately 50 tons of cold patch filling potholes this winter.

Communications from the Mayor:

- Noted that the city will extend leaf pick-up through February 16, 2018, due to the recent inclement weather affecting the clean-up schedule.
