## Board of Mayor and Aldermen Meeting January 7, 2019 Dyersburg Municipal Court Room

(1) <u>Call to Order:</u> The Board of Mayor and Aldermen met in regular session on Monday, January 7, 2019 in the Dyersburg Municipal Court Room at 7:00 p.m. Mayor John Holden presided over the meeting. The meeting opened with prayer by Alderman Dennis Moody. Mayor Holden noted all Aldermen were present, with the exception of Aldermen Kevin Chaney, Mike Morgan, and Robert Taylor, Jr.

# (2) <u>Approval of Minutes:</u>

Mayor Holden called for a motion to approve the minutes from the December 3, 2018 meeting. Alderman Dennis Moody made a motion to approve the minutes. Alderman Scott Staggs seconded the motion. The minutes were approved.

- (3) <u>Unfinished Business:</u> None presented.
- (4) New Business

# a. Attorney Invoice

Mayor Holden presented an invoice from the City Attorney's office to be approved for payment. The November 1, 2018 – November 30, 2018 invoice totaled \$ 4,481.25. Alderman Bob Kirk made a motion to approve the payment, with a second by Alderman Bill Escue. The motion passed by full Board approval.

In additional discussion, Alderman Bob Kirk opened discussion involving the most recent meeting in November 2018 between the City and representatives of the operators of the McDowell Center (Keystone- lessee) regarding a potential purchase of the property. Mayor Holden noted that the November meeting was the second meeting of discussion with Keystone, and that no further interest had been exhibited by Keystone as a potential purchaser of the property.

 b. Notice of Public Hearing – January 21, 2019 – An ordinance amending the Dyersburg Municipal Zoning map by rezoning property located near 427 Fairbanks Road (Clarence Carthen property) from M-2 (medium industrial) district to B-2 (general trade and services) district.

Mayor Holden presented an ordinance recommendation from the Regional Municipal Planning Commission calling for a motion to approve the ordinance for public hearing. Alderman Dennis Moody motioned for approval, followed by a second from Alderman Terry Glover. The motion was approved and will be presented for public hearing January 22, 2019.

## (8) Communications from retiring Board Members

The retiring Board of Alderman and Mayor generally thanked one another for the privilege of working together, and the citizens who elected them and for the opportunity to have served the community over the last four years. All wished each the best in the new year and in future endeavors. Finally, they offered support to the newly elected Board of Aldermen.

Each Alderman presented final comments as follows:

Alderman Bob Kirk: asked the about the current status of the City of Dyersburg audit.

City Treasurer Steve Anderson came before the Board and mentioned a draft copy of the Dyersburg City School System's audit had been received.

"The draft copy should be the final copy unless they have changes in their review," said Anderson. "It's enough for me to get the information I need to write our audit, but I'm still waiting on information from our auditors to finish up on it."

Alderman Kirk stated he thought the audit should have been completed by December 1, 2018. (The Board of Mayor and Aldermen approved Cowart Reese Sargent to replace Alexander Thompson Arnold during the June 4, 2018 meeting with a 5-4 vote in favor of the change. Alderman Kirk mentioned he was told by Joe Enoch of the Cowart Reese Sargent firm the audit would be completed by Dec. 1, 2018).

"Is there some reason they couldn't get it in on time?" asked Alderman Kirk.

"The Pension Plan is one of the big things," responded Steve Anderson. "I think they may be underestimated what it was going to take to do this audit. The Pension Plan, as far as I know, is the major holdup for them."

Mr. Anderson also noted the firm has asked for a one-month extension, which would allow the firm to have it completed by January 31, 2019.

Alderman Kirk did not seek re-election as alderman having completed 51 years of service.

He expressed his appreciation to those in attendance at the meeting. He thanked his family and friends for allowing him to serve the community for 51 years.

"I encourage you new members to vote with confidence, conviction, independence, common sense, and integrity," said Kirk. "These principals will serve you and this community well."

He encouraged new members to ask questions and never fail to recognize the many city employees with wages, benefits, and a pat on the back.

Alderman Kirk quoted the Jaycees service creed stating, "Service to humanity is the best work of life. You [new board members] have found a wonderful way to serve humanity by being on this board."

Upon completion of his final address as an alderman, Mr. Kirk received a standing ovation from those present.

Alderman Bill Escue: who did not seek re-election, mentioned it was an honor to serve the citizens of Dyersburg. He added he enjoyed working with all of the department heads, and that his time as an alderman has been a great learning experience. He also congratulated the new board members. Alderman Escue also congratulated Alderman Kirk for his service.

Alderman Terry Glover: who also did not run for re-election, stated he has been blessed to work with the fellow board members over the years.

"When I look at the crowd here and look at who's up here, I see former students," said Glover. "It's great that I got to know what was happening. My purpose originally was to pay back to Dyersburg for what they've given me and my family. I have totally been blessed. Thank you for the opportunity." He also encouraged the new members to get to know the city's department heads.

Alderman Kevin Chaney: Not present

Alderman Mike Morgan: Not present

Alderman Dennis Moody: Comments reserved at the end of the meeting.

Alderman Scott Staggs: who was appointed in January 2018 following the resignation of Carolyn Norman, mentioned he felt a calling to serve his city.

"I love this city with all of my heart," said Staggs. "I've loved getting to know these guys, and I piggyback off of what they said about meeting the department heads. I know with the people coming in, we have a lot of fine people to represent this city."
