(1) <u>Call to Order:</u> The Board of Mayor and Aldermen met in regular session on Monday, May 20, 2019 in the Dyersburg Municipal Court Room at 7:00 p.m. Mayor John Holden presided over the meeting. The meeting opened with prayer by Alderman James Baltimore. Mayor Holden noted all members of the Board were present.

## (2) <u>Approval of Minutes:</u>

Mayor Holden called for a motion to approve the minutes from the May 6, 2019 meeting. Alderman James Baltimore made a motion to approve the minutes. Alderman Wille Cole seconded the motion. The minutes were approved.

- (4) New Business
- a. Public Hearing Beer Permits

The Hideaway 551 Horner Road Dyersburg, TN 38024

Mayor Holden announced that this was a public hearing for this permit request. Dyersburg Police Chief, Steve Isbell presented information stating that the background investigation of the beer permit applicant showed no reason for the applicant to be denied from obtaining a beer permit for the business for on premise consumption. Being this was noticed as a public hearing, Mayor Holden called for any persons to speak regarding this permit application. No public comment was presented. Mayor Holden entertained a motion for approval of the application. Alderwoman Mary Claire Hopper made a motion to approve the application, followed by a second from Alderman Willie Cole. The motion passed by full Board vote.

Dyersburg Police Chief, Steve Isbell presented information stating that the background investigation of the beer permit applicant showed no reason for the applicant to be denied from obtaining a beer permit for the business for on premise consumption. Being this was noticed as a public hearing, Mayor Holden called for any persons to speak regarding this permit application. No public comment was presented. Mayor Holden entertained a motion for approval of the application. Alderwoman Vanedda Webb made a motion to approve the application, followed by a second from Alderman Willie Cole. The motion passed by full Board vote.

#### b. Dyer County Promise Scholarship – Dr. Karen Bowyer, President, Dyersburg State Community College

Dr. Karen Bowyer, President of Dyersburg State Community College, and DSCC student Anna Flowers presented a request for the City to continue its support of the Promise Scholarship. Dr. Bowyer provided the Board with current information about the economic impact of DSCC upon the community totaling @ \$61,000,000.00. She noted students will need the scholarship to support many needs including books and transportation.

Ms. Flowers stated that not all students who qualify for the scholarship receive it, due to unforeseen circumstances. Additionally, Ms. Flowers presented her personal life story and how this scholarship program has significantly and positively affected her success in college.

Dr. Bowyer stated that since the inception of the scholarship contribution in 2007 many hundreds of students have benefited from the scholarship support funds, and she encouraged the Board of Mayor and Aldermen to continue the City's support for the Dyer County Promise Scholarship.

The Board recognized the impact and success of the DSCC in the Community, and thanked both Dr. Bowyer and Ms. Flowers for their work and commitment to the scholarship.

#### e. Recognition of National Police Week - Presentation of Awards – Police Chief Steve Isbell

Police Chief Isbell presented recognitions honoring fallen officers as part of the National Peace Officers Memorial Day, and to recognize several officers for National Police Week who will receive awards for their service to the community.

He noted that National Peace Officers Memorial Day was signed into law by President John F. Kennedy, on October 1, 1962, and is observed annually each May 15th. The memorial honor is to honor all the men and woman who have died in the line of duty protecting their communities. He stated that in 2018 (163) officers were killed in the line of duty, and so far in 2019 (44) officers and (5) K9 dogs have died.

He honored all who have died making the ultimate sacrifice, and recognize local officers who have made an impact on the Dyersburg Police family including Dyersburg Police Detective Frank Maynard, was shot and killed in the line of duty on July 25, 1975. Additionally, Lauderdale County Sheriff's Deputy Kevan Maurice Ward, was shot and killed on January 2, 1990.

Chief Isbell further recognized and presented the following officers with awards for their service in the Dyersburg community. The Distinguished Service Ribbon was awarded to Lieutenant Jason Alexander, Field Training Officer Thomas Pollock, Field Training Officer Heather DeFoe, Field Training Officer Thomas Harber, Lieutenant Bill Danley, K-9 Officer Brad Perkins and SRO LaQuinta Ward. The Police Life-Saving Ribbon was awarded to Field Training Officer Thomas Harber, Officer Brandon Wheeler, Officer Wesley Blankenship and Officer Jesse McNeil.

Chief Isbell praised all the men and women of the Dyersburg Police Department, and their families for their contributions to the community.
