Board of Mayor and Aldermen Meeting August 5, 2019 Dyersburg Municipal Court Room

(1) <u>Call to Order:</u> The Board of Mayor and Aldermen met in regular session on Monday, August 5, 2019 in the Dyersburg Municipal Court Room at 7:00 p.m. Mayor John Holden presided over the meeting. The meeting opened with prayer by Alderwoman Mary Claire Hooper. Mayor Holden noted all members of the Board were present.

(2) <u>Approval of Minutes:</u>

Mayor Holden called for a motion to approve the minutes from the July 15, 2019 meeting. Alderwoman Mary Claire Hopper made a motion to approve the minutes. Alderman Wille Cole seconded the motion. The minutes were approved.

- (4) New Business

a. Public Hearing – Ordinance BB693 – An ordinance to establish a Planned Commercial District (PCD) overlay district for property located along U.S. Highway 51 near its intersection with Parr Avenue.

Mayor Holden declared a public hearing for Ordinance BB693 – An ordinance to establish a Planned Commercial District (PCD) overlay district for property located along U.S. Highway 51 near its intersection with Parr Avenue. The ordinance was duly published in the Dyersburg State Gazette. Mayor Holden called for any persons present to provide any public statement before the Board. No public statement was presented. Mayor Holden called for a motion to approve Ordinance BB693. Alderman James Baltimore motioned for approval, followed by a second from Alderman Ricky Hammond. The ordinance was unanimously approved.

ORDINANCE BB693

AN ORDINANCE AMENDING THE DYERSBURG MUNICIPAL ZONING MAP BY ESTABLISHING A PLANNED COMMERCIAL DISTRICT OVERLAY ZONE ON PROPERTY (FOUR JEWELS L P) LOCATED ON U.S. HIGHWAY 51 BYPASS AND PARR AVENUE.

WHEREAS, pursuant to <u>Tennessee Code Annotated</u> Sections 13-7-201 and 13-7-202 a zoning ordinance and map have been adopted for the City of Dyersburg; and,

WHEREAS, the Dyersburg Municipal-Regional Planning Commission has recommended that the following property be reclassified by establishing a Planned Commercial District Overlay Zone and,

WHEREAS, a public hearing was held before Dyersburg Board of Mayor and Aldermen pursuant to section 13-7-203, <u>Tennessee Code Annotated</u>, the time and place of which was published with fifteen days advance notice; and,

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF DYERSBURG:

SECTION 1. That the following described property be rezoned to B-2 (General Trade and Services) District:

Parcel 10.02 on Dyer County Tax Map 088 and a portion of Parcel 59.00 on Dyer County Tax Map 074.

PROPERTY DESCRIPTION
