Board of Mayor and Aldermen Meeting Monday, May 16, 2011, 7:00 P.M. Municipal Building – Courtroom

- (1) <u>Call to Order:</u> The Board of Mayor and Aldermen met in regular session on Monday, May 16, 2011 in the municipal courtroom at 7:00 p.m. Mayor John Holden presided. All Board members were present, except for Alderwoman Joan Wyatt. The meeting opened with the "Pledge of Allegiance to the Flag" followed by prayer by Kevin Chaney.
- (2) <u>Approval of Minutes:</u> Minutes of the May 2, 2011 meeting were approved on a motion by Ms. Horner, followed by a second from Mr. Williams. The motion passed approving the minutes.
- (3) **<u>Unfinished Business:</u>** None to report.
- (4) **New Business**:
 - **a.** Notice of Public Hearing June 6, 2011 Zoning Ordinance and Map Amendment, M-3 Industrial.

Formal notice was given by the Mayor and Alderman Board for the upcoming public hearing at the June 6, 2011 Board meeting.

Report from Alderman and Alderwomen:

Alderman Bob Kirk: Urged citizens to use caution in allowing private tree contractors to place contracted tree cutting debris along curbside. Recommended the street and sanitation committee review its polices for future recommendation to the Board regarding this matter.

Alderman Bart Williams: Mentioned that as part of recommendations from Walkability expert Mark Fenton and the Pioneering Healthy Communities local group, chaired by YMCA director Randy Butler, there is a need for local bicycling expertise to assist in the future design and creation of bicycle routes within the City.

Alderman Terry Glover: No report.

Alderman Kevin Chaney: Expressed the need for the City to respond to the maintenance of houses and properties that have been foreclosed and are unmaintained. Mr. Thomas Mullins, Dyersburg City Codes Enforcement stated that this issue was very difficult to deal with. He stated the main reason is finding the appropriate responsible bank related businesses to stand responsible for the individual foreclosures. He said that too often the trail of responsibility was passed along from one bank to another. He stated the Street Department and Codes Enforcement were carrying out the functions of mowing and house condemnation as appropriate to the needs of the communities and surrounding properties. Notices are being sent to the last known owner and actions are being taken.

Alderwoman Jewell Horner: Asked for an update as to when the City sanitation curbside removal of limb and yard debris would return to the normal schedule. Mayor Holden stated the storms of April 24-26, 2011 had prompted significant clean up, and had interrupted the normal

schedule. Mayor Holden will check with the sanitation department the following day from the tonight's meeting as to the schedule.

Alderman Dennis Moody: No Report.

Alderwoman Joan Wyatt: Not present.

Alderman Robert Taylor, Jr.: Thanked the Chief of Police for assisting with controlling speeding on Hornbrook. He reminded the residents of his district of a community meeting to be Saturday, May 21, 2011 at 10:00 a.m., at the old Dyer County School.
