

**Board of Mayor and Aldermen Meeting  
September 19, 2016  
Dyersburg Municipal Court Room**

- (1) **Call to Order:** The Board of Mayor and Aldermen met in regular session on Monday, September 19, 2016 in the Dyersburg Municipal Court Room at 7:00 p.m. Mayor John Holden presided over the meeting. The meeting opened with prayer by Alderman Dennis Moody. Mayor Holden noted all Aldermen were present, with noted absences of Aldermen Terry Glover and Robert Taylor, Jr.
- (2) **Approval of Minutes:** The minutes of the September 6, 2016 meeting were approved on a motion by Alderwoman Carolyn Norman, followed by a second from Alderman Bill Escue. The motion passed approving the minutes.

**a. Public Hearing – Beer Permit –

Mayor Holden announced notice of public hearing on this permit request. Police Chief Steve Isbell presented information stating that there did not appear to be anything found in the background investigation for this beer permit that would show the applicant unworthy of obtaining a beer permit for the business. He further noted the applicant had already obtained a Liquor by the Drink permit from the State of Tennessee ABC.
