### A Message From the Chief

I am pleased to announce the 2022 Dyersburg Police Department Annual Report. Our report reflects the dedication and proactive policing that our team of 60 commissioned officers, 9 support staff, and 17 traffic support personnel do providing public safety to our community. We strive to provide professional services to our community by maintaining high standards and training that far exceeds the State mandatory police training requirements. The department maintains international law enforcement accreditation through (CALEA) Commission on Accreditation for Law Enforcement Agencies. There are more than 18,000 law enforcement agencies with less than 5% achieving CALEA accredited status. Additionally, the department is accredited through (TLEA) Tennessee Law Enforcement Accreditation. Accreditation is not a mandatory requirement of law enforcement agencies; however, we feel it necessary to pursue excellence and provide quality public safety to our community.

I am also pleased to announce that the department started the process in 2022 to be considered for funding made available through Tennessee Governor Bill Lee's initiative to provide financial aid to law enforcement agencies. The funding is to combat violent crime in our State. We partnered with five other law enforcement agencies in Northwest Tennessee, and agreed to apply and manage the competitive grant. We were awarded \$1,270,000, which will be used to add 83 license plate readers from Ripley to South Fulton and to purchase and maintain equipment needs of each agency. The Dyersburg Police Department was awarded an additional \$278,000 through the formula grant which is also a competitive grant. We will utilize those funds to purchase 18 Skycop cameras and other equipment needs utilizing technology to assist us in fighting violent crime. We continue to build upon police and community relationships through our Community Changer initiative to enhance quality of life and reduce crime.

City of Dyersburg Mayor John Holden and Board of Aldermen support and fund the department ensuring we have the training, tools and other resources needed to provide public safety for our community. We are thankful for their support.






### Organizational Structure

### Accreditation

The Dyersburg Police Department is one of just six agencies in West Tennessee to earn the esteemed distinction of being an Internationally Accredited Agency. Out of over 18,000 law enforcement agencies in the United States, we are proud to belong to the exclusive 5% that have been granted CALEA accreditation.

Additionally, our department holds state accreditation through the Tennessee Law Enforcement Accreditation Program (TLEAP), a recognition bestowed by the Tennessee Association of Chiefs of Police.

We operate as a full-service agency, providing round-the-clock coverage to our community. To support our mission, the department operates with an annual budget of 6.8 million dollars and maintains a dedicated team of 69 personnel.

### Response to Resistance Risk Management Analysis

During the calendar year of 2022, officers of the Dyersburg Police Department responded to a total of 26,914 calls for police service. Of these calls, there were a total number of 2,278 arrests made. Of these arrests, 2,012 were adults and 266 were juveniles.

When comparing this number to the 1,978 total arrests made in 2021, it was discovered that the Dyersburg Police Department made 300 more arrests in 2022, which is an estimated 13.7% increase.

There has been a total of 108 Use of Force incidents reported in 2022, an increase of 13.89% from the 2021 reported Use of Force incidents of 93. This equates to an estimated average of 1 Use of Force incident out of every 24.5 arrests made. Of the 2,278 arrests made in 2022 a Dyersburg Police officer had to use some type of force 4.7% of the time.

Of the resistant offenders arrested by the Dyersburg Police Department in 2022, 13 were juveniles and 93 were adults.

#### **2022 Encounter Types:**

Of the 108 total Use of Force reported, 83 were during misdemeanor arrests and 25 were for felony arrests.

#### **Summary of Analysis**

#### **Physical Force:**

As a result of all physical force utilized by members of the Dyersburg Police Department in 2022, there are 12 incidents that caused an injury to a suspect, and only two (2) incidents that required some degree of medical attention. Medical treatment was made available in every incident as soon as the officer was able to safely do so. This demonstrates that officers are following the Dyersburg Police Department Response to Resistance Policy regarding assistance to the injured.

#### **Impact Weapons:**

In 2022 there were no reported instances where the Asp Baton was used to subdue a resistant subject.

#### **TASER:**

The use of the Taser CEW has increased by 33.3% in 2022. There was a total of 12 Taser CEW deployments in 2022 compared to the 8 deployments in 2021. There were 2 reported Taser CEW deployments in which officers energized the subject more than once. In each of these incidents, the subject continued to resist arrest after they received the initial deployment. Overall, officers have made excellent force decisions when the Taser has been applied, but are not over-reliant on the Taser CEW.

#### **Pursuits:**

In 2022 there were 43 incidents where a suspect evaded arrest in a motor vehicle. Compared to the 32 instances of motor vehicle evasion in 2021, there has been a 25.5% increase in felony evasions. Of these felony evasions, there was only one (1) pursuit reported. The one (1) pursuit that occurred was determined to be within policy. When faced with suspects who resist by evading in a motor vehicle, officers are accurately choosing not to pursue with little or no supervisory input in the decision making. This continues to demonstrate the effectiveness of our policy and training in Emergency Vehicle Operations that only allows for violent, felony pursuits.

#### **Chemicals:**

In 2022 showed a total of 15 uses of chemical agent, or a 13.3% increase, compared to the 2021 reported 13 uses of chemical agent. There were no injuries to suspects as a direct use of the chemical agent. Of the 15 incidents that the chemical agent was utilized as a force option, officers were able to decontaminate 12 of the suspects either on scene or upon arrival at the correctional facility, with the aid of correctional officers. The other two instances were met with lack of cooperation by the suspects.

#### Weapons:

There were no weapons deployed in 2022.

#### **Assault on Sworn Officer Review**

During the calendar year of 2022, officers of the Dyersburg Police Department responded to a total of 26,914 calls for police service. Of these calls, there were a total number of 2,278 arrests made. Of the 2,278 arrests, 2,012 were adults and 266 were juveniles.

While performing their duties there were a total of eight (8) officers of the Dyersburg Police Department assaulted.

Of all 108 Response to Resistance encounters there were a total of three (3) members of the Dyersburg Police Department injured during a Response to Resistance incident.

Out of the three (3) incidents there was only one (1) instance that resulted in the officer receiving medical treatment. One (1) of these assaults occurred while officers were investigating a felony while the remaining two (2) incidents were misdemeanor offenses. One (1) of the incidents that occurred had a juvenile offender, while the other two (2) were adults.

The review did not reveal any unusual mistakes upon the officer's behalf or trends. Even so, training on pre-assault/threat indicators continues to be implemented within all facets of training as well as de-escalation strategies, defensive tactics, and the use of less lethal tools (spray, baton, and taser).

#### **Resistant Subject Demographics**

#### **White Males:**

Resistant subjects for this category decreased from the total of 46 in 2021 to a total of 40 in 2022. This is a decrease of 15% from the previous year.

#### **Black Males:**

Resistant subjects for this category decreased from 38 in 2021 to 33 in 2022. This is a decrease of 15% from the previous year.

#### **White Females:**

Resistant subjects for this category decreased from 16 in 2021 to 11 in 2022. This is a decrease of 45.4% from the previous year.

#### **Black Females:**

Resistant subjects for this category increased from 10 in 2021 to 23 in 2022. This is an increase of 56.5% from the previous year.

#### **Hispanic Males:**

Resistant subjects for this category decreased from 3 in 2021 to a total of 1 in 2022. This is a decrease of 200% from the previous year.

#### **Hispanic Females:**

There were no reports of resistance within this demographic.

#### **Commentary:**

Officers of the Dyersburg Police Department continue to demonstrate sound judgment in all use of force encounters, following the legal guidelines of State and Federal law and the policy, procedures, and training of the Dyersburg Police Department. This could not be done without the support of the Dyersburg Police Department's leadership regarding the continued training and education of our officers.

Based on the findings of this analysis of the Dyersburg Police Department Response to Resistance it is recommended that the focus on high quality training and the continued education of our officers continue.
